Dear Roger,

I am sorry for not replying earlier. You have raised a very valid point. We are aware of methodological issues, one of which is dealing with repeated replies.

When we published the surveys, we had two options:

- a) Use the provision offered by the hosting company to block repeated replies using IP addresses. This, however, will block legitimate use of the same computer, such as in our laboratory, where numerous participants use the same PCs.
- b) Not to block multiple replies and allow for the possibility of repeated replies when evaluating the data.

We chose option b), which was more practical in our situation.

I took the liberty of attaching an paper by Whitehead (2007), addressing some of these issues.

For some subjects, the climate data will be identified as such whereas for other subjects (chosen at random) they will be presented as stock prices.

Upon completion of the graphical task, subjects will be presented with 3-4 questions about their impressions of scientific certainty. For example, people will be asked how certain they think scientists are about the association between emissions and climate change, HIV and AIDS, and tobacco smoke and lung cancer (using a scale from 0-100%). For each item, participants will also provide their own subjective certainty rating (i.e., "how certain are that human emissions [HIV] are largely responsible for climate change [AIDS]").



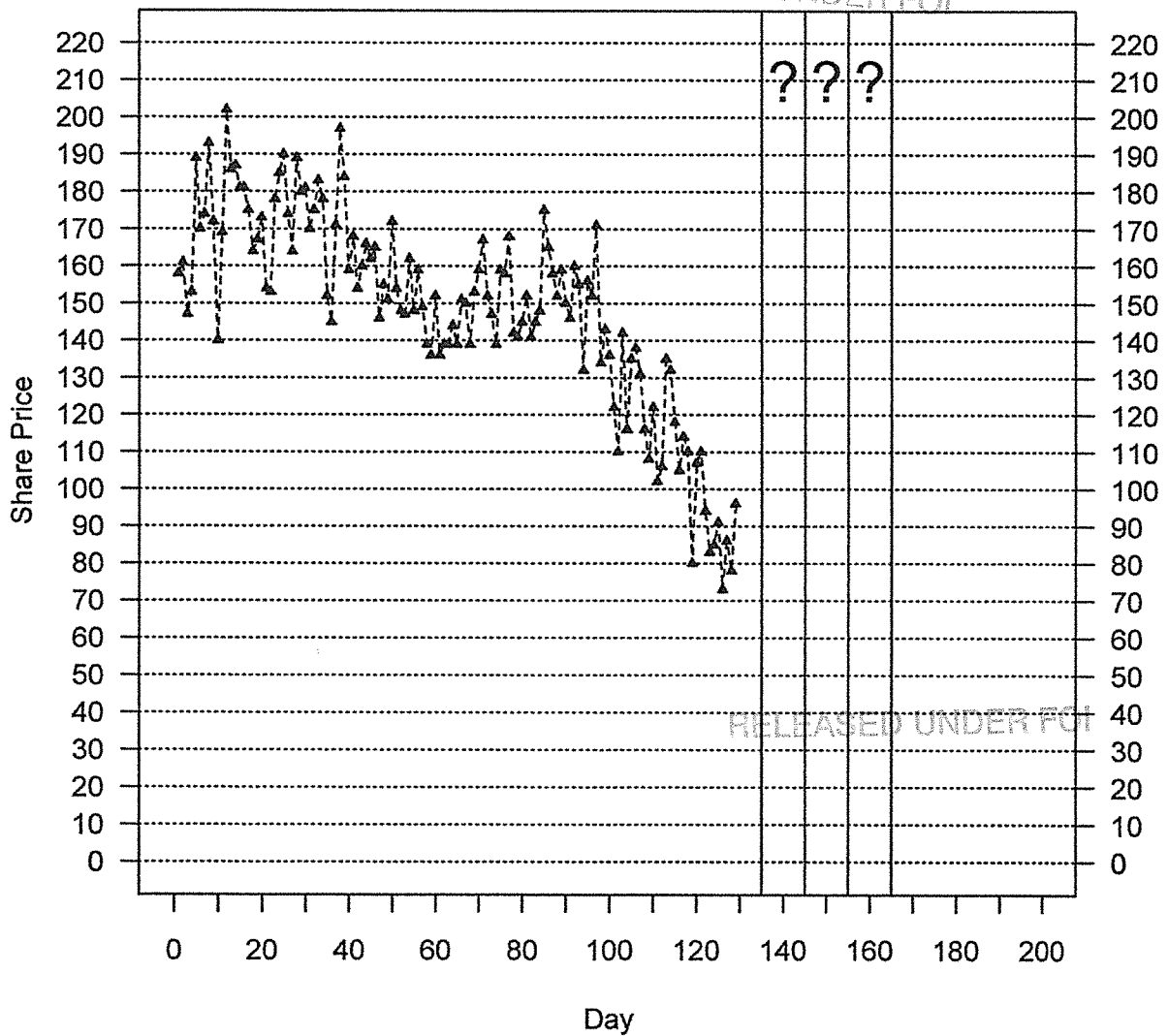

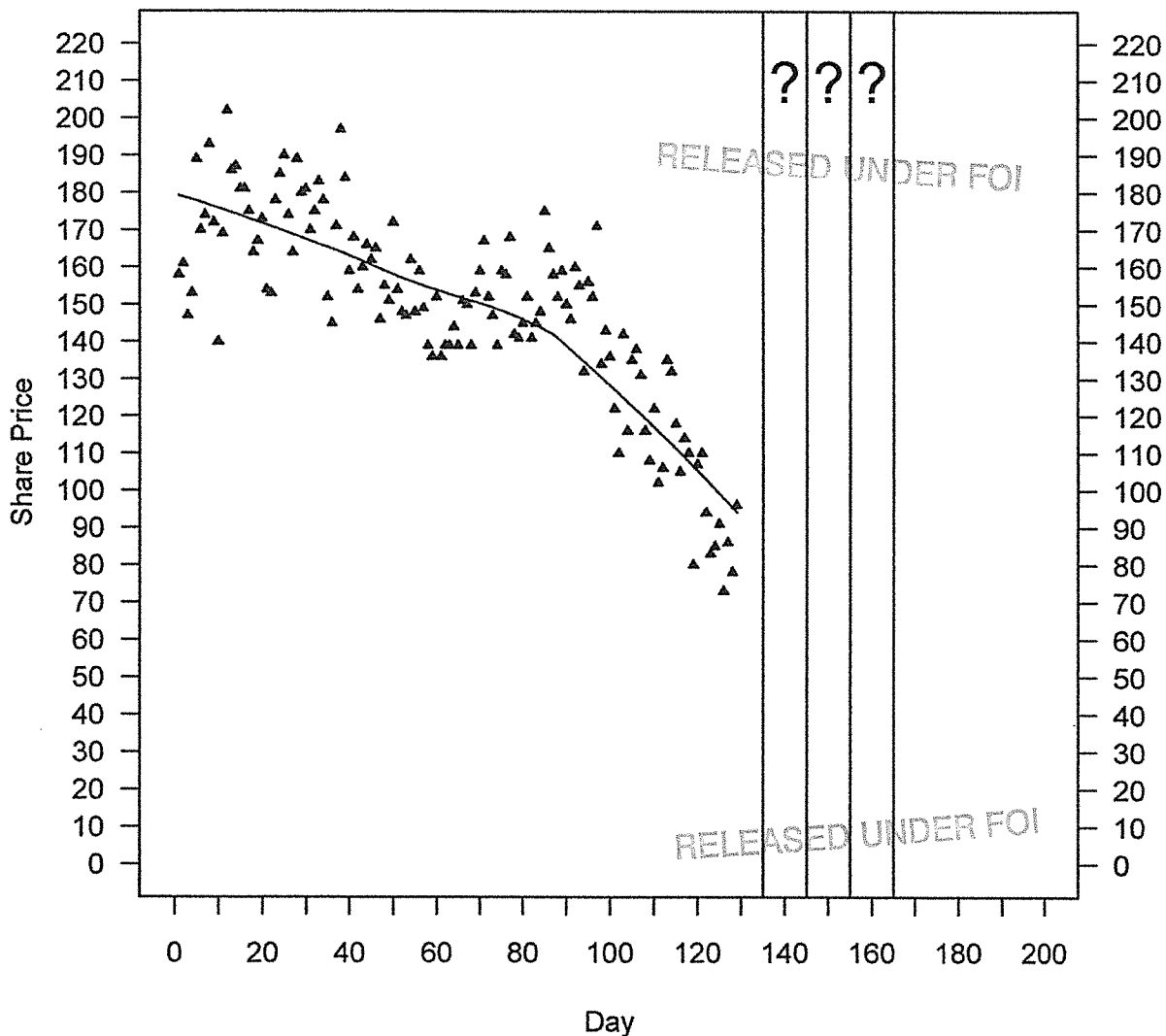
